
Project goals

Project technical parameters

Land plot characteristics:

- area: 250 ha, with the possibility of expanding to 1 000 ha;
- intended use: industry land;
- cadastral number: 1223581800:03:001:0010.

Engineering infrastructure:

Water supply:

1. drinking water (manager – State Interdistrict Enterprise water-and-sewage facility «Dnipro-West Donbass»:

- power reserve of drinking water supply 15000 m³/day;
- distance from IP to water pipe 2,5 km, Ø 1200 mm;

2. drinking water disinfected with chlorine (manager – Public utility «Pavlohrad production directorate of water-and-sewage facility» of Pavlohrad city council:

- power reserve of drinking water supply 5000 m³/day;
- distance from IP to water pipe 1,6 km, Ø 600 mm;

Water disposal – 80 m³/ h (manager – Public utility «Pavlohrad production directorate of water-and-sewage facility» of Pavlohrad city council)

Power supply:

- «PZTO» substation 150/10/6 kV (manager PJSC «Enterprise for the operation of electrical networks «Central Energy Company»), has sufficient power reserve to connect 10 MW;
- distance from industrial park to «PZTO» substation 600 m;
- power supply reliability category II;
- power line connection voltage 10 kV;

Gas supply – 3 thousd. m³/ h;

Transport infrastructure:

- approach automotive roads for trucks and railway transport are located along the land plot;
- European highway: E50 (M-04) 1 km;
- railway stations: «Pavlohrad-2» 1 km and «Pavlohrad-1» – 11 km;
- «Dnipropetrovsk» international airport 92 km;
- «Dnipropetrovsk» river port 83 km;
- Mariupol commercial sea port 272 km;
- the city of Dnipro 82 km;
- the city of Pavlohrad 0 km.
