



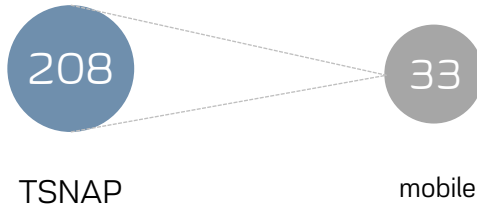

1. Administrative services centers

To support the effective operation of business in the Dnipropetrovsk region there are more than 200 Administrative Service Centers (TSNAP), of which 33 are mobile:



Dnipropetrovsk region is the leader among Ukrainian regions by the number of TSNAPs. In total, more than 241 access points to administrative services operate in the Dnipropetrovsk region.

There are more than 100 online administrative services available to businesses in the region and the main ones being:

3. Consulting portal – Diia.Business



Diia.Business portal – is the one stop-shop for entrepreneurs, SMEs, where anyone can get information. Consultations in more than 65 different areas are available here, as well as a free online school for entrepreneurs. The portal is an perfect start for those who are just planning to start their own business or want to improve their skills and knowledge in certain areas.

4. Open e-procurement resource – Prozorro



Prozorro – is a system of open electronic government procurement in Ukraine according to EU standards.

The ProZorro system allows you to take part in open tenders through online auctions. Non-residents of Ukraine may take part in auctions on the basis of the Law of Ukraine «On Public Procurement». According to this law:

- home and foreign participants of all forms of ownership and legal forms are involved in procurement procedures on equal conditions;
- executive authorities carry out procurement via the ProZorro system, if the cost of goods and services is more than **UAH 200 thousd.**, and works – **UAH 1.5 mln**;
- the state enterprises – monopolists are required limits for goods and services – **UAH 1 mln**, works – **UAH 5 mln**.

Prozorro platforms – is the part of Prozorro through which Customers and Suppliers work in the system.

5. E-Auctions resource – Prozorro.Sale



Prozorro.Sale – the system of online auctions for the sale and lease of property.

Through a system of electronic auctions, businesses gain access to the acquisition of unique assets owned by the state:

- [privatization](#);
- [lease of state and municipal property](#);
- [bankruptcy](#);
- [assets of private companies](#);
- [sale of assets of bankrupt banks](#);
- [land market](#);
- [sale of property of state companies](#);
- [rental of freight cars «Ukrzaliznytsia»](#).

Prozorro.Sale auctions are state auctions that guarantee transparency and are regulated by law to ensure fair bidding.

6. Taxes and Taxpayer Service Centers



In Dnipropetrovsk region there are 34 Taxpayer Service Centers of the [Main Department of the State Tax Service](#), which provide above 80 administrative services (\approx 50 - are free) to individuals and legal entities, in particular:

- providing references about the registration number of a taxpayer's registration card from the State register of individuals-taxpayers;
- providing references about the absence of debt payments to the budget controlled by the State Fiscal Service of Ukraine;
- registration of books of records, payment operations, account books, registers of payment operations;
- registration of single tax payers;
- registration of income and expenditure ledger of single tax payers;
- provision of advices on tax law etc.

Taxes in Ukraine:

- company income tax: 18%;
- value-added tax (VAT): 20%;
- unified social tax: 22% of the wage fund;
- personal income tax: 18% of the salary employed person;
- real estate tax: up to 2% of the minimum wage per m²;
- land tax: from 1 to 12% of the land normative monetary estimate.

Simplified taxation system

The simplified taxation system (single tax) can be used by both individual entrepreneurs and resident legal entities. The simplified taxation system is divided into **four groups**:

I group

individual entrepreneurs who do not use the hired persons labor:

- carry out exclusively retail sale of goods from trading places in the markets and carrying out economic activities providing personal services to the citizens;
- the amount of income during the year does not exceed **UAH 1.2 mln**

The single tax rate for the Group 1 is up to **10%** of the minimum wage

Social contribution tax **22%** of the minimum wage.

II group

Individual entrepreneurs who employ less than **10 persons**:

- the amount of income during the year does not exceed **UAH 5,9 mln**;
- that conduct business activity to provide public services, including household (to single tax payers and population);
- production and sale of goods, restaurant business activity.

The single tax rate for the Group 2 is up to **20%** of the minimum wage

Social contribution tax **22%** of the minimum wage for each employee.

III group

Individual entrepreneurs and legal entities:

- the amount of income does not exceed **UAH 8.3 mln**;
- unlimited number of employees.

The single tax rate for the Group 3 is **3%** of income and VAT payment or **5%** without VAT

Social contribution tax **22%** of the minimum wage for each employee.

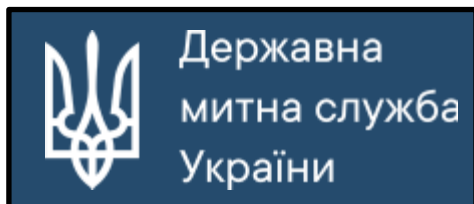
IV group

Legal entities, agricultural producers, whose share of agricultural commodity production for the previous tax year is equal to or greater than **75%**.

A single tax is levied on land on which the rights of ownership and use are formalized and registered in accordance with the legislation.

The amount of tax rates per hectare of agricultural land and/or water fund land depends on the category (type) of land, their location.

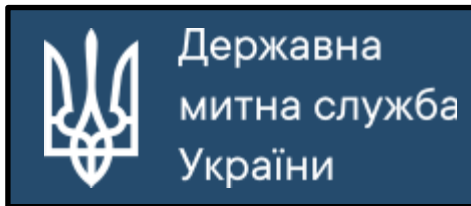
7. Customs posts



There are [8 customs posts and 5 customs service departments \(CMS\)](#), in the region which carry out customs clearance processes, from border crossing to paying customs duties and putting them into free circulation on the territory of Ukraine:

7. Customs posts



The indicated customs posts cover all transport routes of the region and provide cargo transshipment services in river ports, railway stations, autoports and aviation cargo terminal.

Main services offered:

- execution of customs procedures related to commercial goods moving across the customs border of Ukraine, including on the basis of electronic documents (electronic declaration), with the help of technical control means, etc.;
- registration of fees (other obligatory payments) when moving goods of commercial purpose through the customs border of Ukraine and carrying out customs procedures;
- application of measures of customs and tariff control during implementation of foreign economic activity.

8. Registration of a land plot for business



Obtaining a land plot for lease is done through an auction.

In case if a land plot has a real estate in ownership on it, the procedure is done without an auction.

Businesses can use the e-services of Gosgeokadastr and order documents necessary for obtaining a land plot through a personal account, for example:

- extract from the Gosgeokadastr for the land plot;
- normative monetary evaluation of the land plot (at it's the location);
- information on owners and users of land plots;
- correction of technical errors in the data of the Gosgeokadastr, etc.

8. Registration of a land plot for business



Due to the martial law in Ukraine, some information products of the Gosgeokadastr, namely land auctions and the public cadastral map are disabled for security reasons.

Information about **land plots of all forms of ownership and real estate objects**, which are submitted to the auction, is available on the [Prozorro.Sale](#) website.

Today, every entrepreneur who wishes has the right to lease state, municipal and private land under open conditions. To do this, it is necessary to be accredited on the website of one of the electronic sites of the "Prozorro.Sale" system to gain access to land auctions.

Currently, the resource Prozorro.Sale placed [more than 20 thousand proposals from Dnipropetrovsk region](#), which include both land and real estate (premises and buildings).

9. Construction permission



Permits for construction in the region are issued by the [State Inspectorate of Architecture and Urban Planning](#) of Dnipropetrovsk region.

10. Environmental impact assessment

Environmental impact assessment is designed to identify the nature, intensity and degree of danger of the impact of any type of planned economic activity on the environment and public health.

The implementation of environmental impact assessment is mandatory for making a decision on the planned activity (in accordance with the Law of Ukraine "On Environmental Impact Assessment", as of 18, December 2017).

10. State Property Fund of Ukraine

Privatization issues are handled by the State Property Fund of Ukraine, which offers objects for business:

- [small privatization](#) - these are not only state enterprises and shareholdings, but also objects of unfinished construction and social and cultural purpose, separate movable and immovable property, the value of which is not higher than 250 million UAH;
- [large privatization](#), which may include only state-owned enterprises and shareholdings with a value exceeding 250 million UAH; - large privatization, which may include only state-owned enterprises and shareholdings with a value exceeding 250 million UAH.

For entrepreneurs, this is a good opportunity to buy something interesting for the development of their business and their community.
