Technical parameters of the IP

Land plot characteristics:

- area: approx: 10 ha, with an estimated construction area of 41,857 m²;
- intended use: industrial land;
- cadastral numbers: 1210700000:01:303:0078, 1210700000:01:302:0024

Engineering infrastructure:

- water supply will be provided from the existing network of the industrial zone. Consumers will be connected to the internal system through a main water supply line (Ø 315 mm) with branches (up to Ø 200 mm).
- water sewage each facility will have its own water treatment system with subsequent discharge into the collector);
- gas supply approximate rate of 80.0 m³/h per 1 ha;
- electricity supply standard design load per 1 hectare of the IP territory is 0.5 MW.

Planned infrastructure on the territory of the IP:

- industrial industrial buildings, warehouse complexes, administrative buildings, technical areas and a chemical plant;
- social infrastructure canteens and cafes (arrangement of places for employees' meals), medical centers and sports grounds;
- green areas green areas for employees' recreation;
- safety and security fences and video surveillance.

- adjacent transport communications: regional highway P74 and territorial highway T1210
- E-50 (European highway) 18 km;
- railway stations: Pyatikhatky (22.0 km), Kryvyi Rih, station Rokuvata (49.0 km), Kryvyi Rih (69.0 km), Dnipro (129.0 km);
- the nearest railway station is Zhovti Vody-1 (fourth class freight and passenger railway station)
