

Dnipropetrovsk region has a favorable geographical position and is located at the crossroads of rail and river routes. These routes connect the east-west (European route E50) and the north-south (European route E105) of the European continent.

The region's strategic location makes it an important hub for transportation and trade, facilitating efficient connections across Europe.

The administrative center of the region is Dnipro, which is situated on the banks of the similarlynamed river.



It is possible to get to the city of Dnipro and other big cities of the region by train and bus.

The high-speed trains of the Intercity and Regional Express categories run between Kyiv, Zaporizhzhia and Dnipro.



### THE DISTRICTS OF THE DNIPROPETROVSK REGION WITH IT'S LARGEST CITIES






Dnipropetrovsk region - is one of the main labor markets in Ukraine, where 1.3 mln people (8.9% out of the total number of Ukraine) of economically active population are concentrated.


The region is one of the best among the regions in terms of working-age population employment - 64.3%. The average salary was \$668,6 in 2025.

Since the beginning of the full-scale invasion launched by the Russian Federation against Ukraine in February 2022, Dnipropetrovsk region has become a huge center for the provision of assistance to IDPs, the relocation of enterprises and higher education and research institutions from the southeast of Ukraine.

As of 2025 year 451 000 internally displaced persons are registered in Dnipropetrovsk region, of which 52% are of working age. The largest number of IDPs are in the cities of Dnipro and Kryvyi Rih.

Training of the personnel is carried out in the region in many educational areas, including through a dual education system to provide future employees with practical work experience at the enterprise.

Every year, higher education institutions of the region train more than 39 600 specialists of various levels of qualification and training.

The educational process in higher education institutions is carried out by 5189 research and teaching staff and 899 pedagogical staff, including 957 doctors of sciences; 772 professors; 3091 candidates of sciences; 2397 associate professors. The total number of employees of higher education institutions amount to 12588. Currently, 4 institutions of higher education and 6 institutions of pre-higher education, where a total of 300 lecturers from Donetsk and Luhansk regions work, will also provide educational services in Dnipropetrovsk region.

In the realities of a full-scale war, air and water transportation was temporarily suspended, so the railway and road transport today remain the main logistics links in the region. The railway connects the industrial centers of the region and helps businesses to carry out export and import operations with neighboring states.

Passenger, humanitarian and military aid transportation are working stably, and international evacuation routes run daily for those wishing to travel out the country.

# ROAD TRANSPORT CONNECTION



The territory of Dnipropetrovsk region is crossed by two European routes connecting the region with seaports, the capital and industrial centers. The largest transport hub here the region is the city of Dnipro. The network of highways connects it with all cities and urban-type settlements of the region and other regions of Ukraine.

The existing European roads allow the enterprises of the region to continue their foreign economic activity.

Active restoration of infrastructure damaged as a result of hostilities continues, as well as the construction of new highways.

### RAILWAY TRANSPORTATION SERVICE



The railway transportation is the main mode of Dnipropetrovsk region transport. By saturation with railways, the region is the leader in the state, the network of railway tracks is 1 023.7 km.

The operator of the railway transportation service in Dnipropetrovsk region is the regional branch «Prydniprovska Railway» owned by the PJSC «Ukrainian Railways».

### AIR AND RIVER TRANSPORT



In the realities of a full-scale war, air and waterway communication on the Dnipro River in Ukraine is temporarily-has been suspended. Railroad and road transport are the main transport logistics arteries in the region.

### HIGHWAY TRANSPORTATION PORTS



There are 6 highway transportation ports in the territory of the region, which provide customs clearance, storage and transshipment of goods.

### **RAILWAY JUNCTIONS**



Dnipro branch of «Center of Transport Service «Liski» of the Ukrainian Railways PJSC includes a network of rail freight terminals that offer:

- customs complex with the representatives of state customs control, environmental and phytosanitary control;
- arrival place of highway transport with cargo under customs control;
- · covered warehouse hangar type;
- platforms for the processing of heavy goods which is equipped with gantry cranes (with the possibility of

connecting an electromagnetic washer to unload metal from gondola cars);

• platforms for processing 3-tons, 5-tons, 20-tons, 40-feet containers.

All cargo facilities have the ability to simultaneously service rail and road vehicles. To meet the needs of customers the department has production sites in some big cities of Dnipropetrovsk region.



### **PREFERENCES**

One of the main foundations of the successful development of the state is an effective system of preferences.

For potential investors engaged in certain economic activities the state provides a number of benefits in the form of tax and customs incentives, financial support, etc.



# EXEMPTION FROM VAT (20%) PROVIDED IN CASE OF:

- Participants of industrial parks

   for new (not older than 3 years) equipment and components imported exclusively for use within the park in the fields of processing industry, waste management, material recovery, or research and development, provided that they are used for their intended purpose for at least 5 years, and there are no similar products produced in Ukraine.
- Import of goods and materials for renewable energy and energy efficiency (including components and raw materials for their production) – provided that such goods are used for own production and there are no domestic equivalents.



# EXEMPTION FROM INCOME TAX (18%):

- Participants of industrial parks for a period of 10 years in the processing or research activities.
- Investors implementing projects with significant investments (in the amount of 20+ million €, 80+ new workplaces, up to 5 years project implementation period).



# STATE FINANCIAL SUPPORT FOR INDUSTRIAL PARKS:

- Compensation of interest payments on credits (loans) for the development and/or implementation of economic activities within industrial parks;
- Provision of funds on a nonrepayable basis for the development of industrial parks and/or the construction of related infrastructure facilities (roads, communication lines, heat, gas, water and electricity supply facilities, engineering communications, etc.);
- Compensation of the costs of connection and accession to engineering and transport networks.

# EXEMPTION FROM IMPORT DUTY TAXATION:

Goods imported by foreign investors within the framework of the Law of Ukraine "On the regime of foreign investment" for the purpose of investing on the basis of agreements (contracts) or as a contribution of a foreign investor to the authorized capital of an enterprise with foreign investments. Foreign investors are: legal entities established in accordance with foreign legislation, individuals - foreigners, foreign states, international governmental and nongovernmental organizations; other foreign subjects of investment activity, determined by the legislation of Ukraine.

Goods, including products, equipment, vehicles, etc., intended for the implementation of a production sharing agreement (an agreement on the distribution of natural resources), as well as products mined in the exclusive (marine) economic zone of Ukraine.



Equipment, scientific, laboratory and research equipment and components for them, materials that are not excisable goods for the arrangement of industrial, scientific and technical parks.\*

Equipment operating on renewable energy sources, energy-saving equipment and materials, means of measuring, controlling and managing the costs of fuel and energy resources, equipment and materials for the production of alternative fuels or for the production of energy from renewable energy sources.\*

Import to the customs territory of Ukraine of materials, units, assemblies and/or components by domestic machine-building enterprises for the agro-industrial complex in order to produce machinery and/or equipment for the agro-industrial complex.\*











### INVESTMENT IN ECOLOGY

Despite the constant increase in the volume of industrial production, the region's enterprises make a significant contribution. The total volume of investments in the ecology protection and improvement of atmospheric air quality, protection and rational use of water resources, optimization of waste management, protection and rational use of land, improving energy efficiency and energy saving in production, transition to alternative energy sources (wind, solar, biomass), development of environmental monitoring systems at enterprises and in cities, in 2024 -\$45.8 mln.

Industry showed growth in 2024, primarily due to key sectors. The highest figures were in the chemical industry (82%), light industry 58.5%), engineering (16%), mining (14%) and metallurgy (13.5%).

The 1.4% decline in the energy sector was primarily caused by targeted attacks by the russian federation on power generation facilities.

The leaders in terms of sales volume were metallurgy (\$5.5 billion), mining (\$3.3 billion) and energy (\$1.3 billion).

The industrial sector is a key component in shaping the export potential not only of the region but also of Ukraine as a whole. Among the exporting companies are the country's industry leaders in metallurgy, mining, titanium and polymer production, chemical elements and products, and light industry products.

The restoration of maritime trade and port infrastructure played a key role in increasing industrial exports, which amounted to 29% compared to last year. As a result, iron ore exports increased, significantly, rising by 64%.

The region's agro-industrial complex sector ranks second in terms of growth, with an indicator of 5.2% and \$3.25 bln of output. The most positive dynamics were demonstrated by the production of oil and animal fats -10% and food production -9.7%.

The region has one of the largest shares of agricultural land in the country, over 2 mln hectares and 6.4% of the country's agricultural output.

Most of the sector's enterprises are mixed farms that effectively combine crop production (mainly grains, oilseeds, and organic crops), livestock (meat production), and processing. The leaders in terms of sales are crop production – \$976.6 mln, oil and animal fat production – \$990 mln, meat production and meat products – \$738 mln. The sector is characterized by the active introduction of the latest precision farming technologies, the development of intensive horticulture and berry growing, investments in the processing of domestic raw materials and focus on the large Ukrainian market.

UNITED TO GROW

The agro-industrial sector, with exports amounting to \$1.057 bln in 2024, was the first among other sectors of the region's economy to exceed pre-war levels. The maritime export corridor created by Ukraine in cooperation with international partners enabled agricultural and processing enterprises to resume steady export flows from Ukrainian ports, which ensured a 28.3% increase in agricultural exports compared to the previous year.

The largest share of agricultural exports is traditionally held by vegetable oil, grains and legumes.

Among food products the leading positions are held by meat products, chocolate, oilcake and bakery products.

The construction sector is showing growth of 2.8%, primarily due to investments, innovations and the expansion of export opportunities. In addition, the region's share in the country's construction sector has increased to 10.8%.

The sector was driven by the building of structures, which grew by 28.9%, and the construction of residential and non-residential buildings, which grew by 3.8%.

The leaders of the construction sector in terms of sales volume are the construction of facilities (roads, railways, communications) - \$572.6 mln and the production of non-metallic mineral products (cement, concrete, and products thereof) - \$422.8 mln.

The reconstruction of the state will require the use of new technologies and innovative building materials in order to restore destroyed objects and create new high-quality living space.



The construction sector's focus on the domestic market, which requires significant renovation work, led to a 22% drop in exports. However, the region's construction sector has significant export opportunities and potential for further growth in international markets. The leader in exports is the production of building materials, in particular building products made of plastics and composite materials. One such company is Ukrkompozit+, whose sanitary ware is widely represented on the market under the MIRAGGIO brand. The region accounts for 20% of Ukraine's wall covering exports thanks to the activities of leading wallpaper factories — ARTGRAND, VINIL and Kontinent. Ukrainian construction companies have experience in implementing projects abroad, including the construction of industrial, residential, and infrastructure facilities.

The services sector showed a slight decline of 0.6% in 2024, primarily due to a decrease in the volume of services provided in the areas of temporary accommodation, catering, administrative and support services. However, the total services output of \$3.3 bln, exceeds the pre-war level.

The fastest growth rates in the sector were demonstrated by IT (12.5%), professional, scientific, and technical activities (6.8%), and transport (4.7%).

The region's service sector is represented by world-renowned IT companies, banking institutions, R&D offices, transport companies, and the country's best healthcare and higher education institutions, which account for 5.9% of the state sector.

IT Dnipro Community is an open public organization that unites 227 IT companies in Dnipro, which together represent over 18,000 IT professionals. The community actively works to develop the region's business environment, support high-quality IT education and strengthen the influence of the IT industry both locally and nationally.

In 2024, \$4 million of foreign direct investment was attracted in the IT industry. A total of \$60.06 million of taxes and fees were paid.
